# **ESSENTIAL JOB FUNCTIONS:\***

- Be a working member of a team oriented group.
- Follow the instructions of the lead counselors.
- Lead and instruct the youth that attend the Park Program.
- Implement daily activities as directed by the lead counselor.
- Prepare fields, courts, and classrooms for instruction.
- Prepare daily time sheets.
- Attend and participate in opening and closing ceremonies.
- Supervise and interact with children during activities and events.
- Supervise and interact with children within your age group.
- Monitor children's interactions within the group.
- Prepare, supervise, and assist kids for the pool.
- Participate in all activities with kids and counselors.
- Promote a cohesive park program team and positive work environment.
- Communicate with superiors and coworkers on concerns and disciplines.
- Perform general routine maintenance as required by supervisors. (E.g. picking up litter, cleaning floors, replacing toiletries, etc.)

- Principles, practices and application of activities and games.
- General rules and regulations pertaining to the LPRD.

### Ability to:

- Adhere to LPRD core values and principles while maintaining a positive image of the organization to members of the community.

- Enforce department rules and regulations while maintaining a safe and secure environment at all times.
- Recognize and mitigate potential hazards and risks.
- Act quickly and calmly in emergencies while notifying the appropriate parties.
- Work cooperatively with diverse populations.
